**AMENDMENT TO THE INTERLOCAL AGREEMENT  
BETWEEN THE CITY OF COLLEYVILLE AND THE CITY  
OF EULESS, TEXAS, FOR THE CONSTRUCTION OF  
HERITAGE AVENUE IMPROVEMENTS BETWEEN  
CHEEK-SPARGER AND GLADE ROAD**

This Amendment to the Interlocal Agreement (the "Agreement") for the construction of paving, drainage, traffic signalization, street lighting and landscaping improvements on Heritage Avenue is made and entered into by and between the City of Colleyville, Texas, a municipal corporation located in Tarrant County, Texas, ("Colleyville") and the City of Euless, Texas, a municipal corporation located in Tarrant County, Texas, ("Euless").

**PREAMBLE**

**WHEREAS**, Colleyville and Euless executed an Interlocal Agreement for Heritage Avenue improvements dated April 2, 2008, and amended on July 7, 2009, and amended again on August 17, 2010; and

**WHEREAS**, the Heritage Avenue improvements identified in the initial Interlocal Agreement have been completed; and

**WHEREAS**, Colleyville and Euless mutually desire to amend Section II, OBLIGATIONS OF THE PARTIES of the "Agreement" to add a Paragraph (10) to provide an additional extension of the concrete pavement on Heritage Avenue.

**AGREEMENT**

**NOW, THEREFORE**, for and in consideration of the mutual covenants, terms and conditions set forth herein, and the mutual benefits to each party, the receipt and sufficiency of which are hereby acknowledged, Colleyville and Euless hereby agree to amend the Interlocal Agreement between the City of Colleyville and the City of Euless dated April 2, 2008, and amended July 7, 2009, and amended August 17, 2010, as follows:

1. Paragraph (10) of Section II. OBLIGATIONS OF THE PARTIES is hereby added as follows:

10. The City of Euless will construct Heritage Avenue as a reinforced concrete pavement section twenty-five feet (25') in width (back of curb to back of curb) from a point approximately 1730 feet south of Glade Road to a point approximately 2430 feet south of Glade Road.

2. All other provisions of the Interlocal Agreement between the City of Colleyville and the City of Euless dated April 2, 2008, and amended July 7, 2009, and amended August 17, 2010, are not changed and remain in effect.
