SUBJECT: Canvassing returns and declaring results of the General Municipal Election held on May 12, 2012

REFERENCE NO: May 12, 2012, General Election

ACTION REQUESTED:

Canvassing returns and declaring results of the General Municipal Election held on May 12, 2012, for the purpose of electing two Council Members to the Euless City Council, Places 5 and 6 to serve terms of three (3) years.

SUMMARY OF SUBJECT:

The Texas Election Code requires the local governing body to canvass the election results not earlier than the third day or later than the eleventh day after election day.

In accordance with the agreement with Tarrant County Elections, Tarrant County Elections tabulated the results and supervised a recount as petitioned by one of the candidates.

As a result of the manual recount, the Recount Supervisor's Report now serves as the official statement of the vote for the Place 5 race.

As no candidate in the Place 5 race received a majority of all votes cast, a subsequent runoff election is required.
