SUBJECT: Bulk Gasoline and Diesel Fuel Contract

REFERENCE NO: Tarrant County – Renewal of Annual Contract for Motor Fuels

ACTION REQUESTED:

Consider approval to purchase various types of automotive and equipment fuel from Douglass Distributing Company through an interlocal purchasing agreement with Tarrant County.

SUMMARY OF SUBJECT:

The City currently purchases fuel from Douglas Distributing Company through an interlocal purchasing agreement with Tarrant County. The initial contract allowed for five (5) additional renewals at the same pricing structure.

Tarrant County Commissioners Court took action on March 12, 2013 to extend the contract for a third year at the same fixed prices.

The current contract will be in effect from April 6, 2013 until April 6, 2014. There are two (2) remaining one (1) year renewal periods under the contract.

There are twenty-four (24) public entities that are served by this contract within a four (4) county area. The items that may be purchased through this agreement are reformulated unleaded gasoline, red dyed off-road usage diesel fuels, E85 Ethanol, and B5/B10/B20 Bio-Diesel fuel. The primary fuels that the city purchases are reformulated gasoline, red-dyed diesel and Bio-Diesel fuels.

Charges will be an average mark down of \$0.0100 per gallon regular unleaded and a mark-up of \$0.0125 per gallon diesel per transport load (4,000 gallons or greater). Bobtail deliveries (3,999 gallons or less) will be charged at a mark-up of \$0.0100 for unleaded and mark-up of \$0.0225 for diesel. All fuel pricing will be based on OPIS (Organization of Petroleum Information Services) daily average net cost per gallon of fuel on the day ordered including dealer markup or mark down plus any federal superfund fees.

The city is exempt from Federal Tax on gasoline and diesel. State tax on diesel is calculated for on-road usage only and is paid on a quarterly basis.
