The minimum elevations are based on the most current information available at the time the plat was filed and may be subject to change. Addition lots, other than those shown, may also be subject to minimum finish floor criteria.

 - Coordinates shown hereon are surface values, with a scale factor of 0.999854198761; no rotation.

 - Within emergency access easements (fire lanes) the roadway surface subgrade, markings and signage shall be maintained at all times to allow for the clear passage of emergency vehicles. Clear passage shall include both horizontal and vertical widths according to clearances established in the Fire Marshal's policy statement.
 - The subject property is located in Zone "X" (areas determined to be outside the 500 year flood plain), according to the Flood Insurance Rate Map No. 48439C0115K, revised September 25, 2009.
 - The City will not maintain any interior drainage systems that originate within this private development.
 - The EADUE & MAE dedicated per the Final Plat of Glade Parks Lots 1 & 2, Block A, recorded in Document No. D211178474 OPRTCT, is hereby abandoned by this plat, and is to be replaced by the EADUE & MAE shown hereon.



OWNER'S CERTIFICATE

WHEREAS We, Glade Infrastructure, LLC, acting by and through the undersigned, its duly authorized agent, is the sole owner of a tract of land situated in the J. BEGINNING at an "X" found in concrete for the southwest corner of said Lot 2 and for the northwest corner of Lot 1, Block A, and for an easterly corner of a tract conveyed to Glade Infrastructure, LLC, recorded in Document No. D214052659 OPRTCT;

THENCE N 08°33'10" W, 63.49 feet along the common line thereof to an "X" set in concrete;

THENCE continuing along the common line thereof, around a tangent curve to the right having a central angle of 07°56'51", a radius of 42.50 feet a chord of N 04°34'45" W - 5.89 feet an arc length of 5.90 feet to an "X" set in concrete;

THENCE N 00°36'19" W, 141.23 feet continuing along the common line thereof to an "X" set in concrete for the northwest corner of said Lot 2, and for an inset corner of said Glade Infrastructure tract;

THENCE N 89°23'41" E, 273.15 feet continuing along the common line thereof to a 5/8" iron rod with plastic cap found on the west line of a right-of-way dedication for State Highway 121, recorded in Document No. D21113566 OPRTCT;

THENCE S 02°15'22" W, 210.25 feet along the west line of said highway to a 5/8" iron rod with plastic cap found for the northeast corner of said Lot 1;

THENCE S 89°23'41" W, 253.46 feet along the common line thereof to the POINT OF BEGINNING with the subject tract containing 55,954 square feet or 1.285 acres of land.

NOW THEREFORE, KNOW ALL MEN BY THESE PRESENTS:

That Glade Infrastructure, LLC, through the undersigned authority, does hereby adopt this plat designating the herein above described property as **GLADE PARKS, LOT 2R, BLOCK A**, an addition to the City of Euless, Texas, and does hereby dedicate to the public use forever the streets and alleys shown hereon; and does hereby dedicate the easements shown on the plat for mutual use and accommodation of all public utilities desiring to use, or using same, said dedications being free and clear of all liens and encumbrances, except as shown herein, Glade Infrastructure, LLC, does hereby bind itself, its successors and assigns to forever warrant and defend all and singular the above described streets, alleys, easements and rights unto the public against every person whomsoever lawfully claiming or to claim the same or any part thereof. No permanent buildings or structures shall be constructed over any existing or platted easement of any type. Any fencing, trees, shrubs or other improvements may only be placed in or over any existing or platted easement of any type with the authorization of the City of Euless or easement holder(s). The City of Euless at the owner's expense, and any easement holder, shall have the right to move and keep removed all or part of any fence, tree, shrub, or other improvements or growths which in any way endangers or interferes with the construction, maintenance, or efficiency of its respective systems on any of the easements shown on the plat; and The City of Euless and any easement holder shall have the right at all times to ingress and egress upon said easements for the purpose of construction, reconstruction, inspection, patrolling, maintaining, and adding to or removing all or part of its respective systems without the necessity at any time of procuring the permission of anyone.
