The class is open to anyone who lives or works in the City of Euless. You must be at least 18 years old in order to enroll. Classes reflect a cross section of the community and are very diverse. Applicants are subjected to a criminal background and warrant check.

In General

You will become acquainted with Communications Officers, Patrol Officers and Firefighters during the 13 weeks of the class. Note that these classes do not train you to become a police officer or firefighter, but do provide a fun and information packed overview to let you get a feel for what the jobs entail. What is the Citizens Academy?

The Citizens Fire-Police Academy is a joint academy presented by the Eules Police and Fire Departments. The academy gives the participants a view of the internal operations of the Eules Police and Fire Departments. The academy also serves as a portal to participation in the separate Eules Citizens Police Academy Alumni and/or the Eules Citizens Fire Academy Alumni groups should you so desire after graduation.

The academy consists of 13 weeks of instruction, followed by a graduation night. Classes are held on Thursday nights from 7-10 p.m. Classes alternate week to week, with police topics one week and fire topics the next. Classes are taught by police and fire personnel who are knowledgeable in the subject being taught. Topics are diverse and include traffic law, traffic stops, use of fire extinguishers, self contained breathing apparatus, tactical team operations, crime scene, fire hose evolutions, criminal investigations, fire investigations and much much more. Many of the classes are hands on, allowing participants to apply what they are learning.

In addition to the Thursday night classes, there are several optional Saturday activities. These include live fire exercises, vehicle extrication and firearms instruction. Persons attending the academy will also be given the opportunity to participate in ride out programs to experience things first hand.

THE OBJECTIVE

The purpose of the Academy is to provide enough information to those citizens who attend that they may make informed judgments about the Police and Fire Departments and their activities. We hope you walk away from the class with a better understanding and appreciation of what it means to be a police officer or fire fighter-paramedic. It is our hope that your increased awareness and knowledge will be shared with friends and neighbors to help further promote understanding and good will between your police and fire departments and the community in which we serve. The departments, in turn, become more aware of the feelings and concerns of the community from the participant's interaction and input. It is a two way learning experience in which everyone wins.
