Required Additional Health Information

To ensure that tap water is safe to drink, EPA prescribes limits on the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water. Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the Environmental Protection Agency's Safe Drinking Water Hotline (800-426-4791).

Contaminants may be found in drinking water that may cause taste, color or odor problems. These types of problems are not necessarily causes for health concerns. For more information on taste, odor or color of drinking water, please contact the system's business office.

The sources of drinking water (both tap and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and radioactive material and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include:

- (A) Microbial contaminants such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- (B) Inorganic contaminants such as salts and metals, which can be naturally-occurring or result from urban storm runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- (C) Pesticides and herbicides which may come from a variety of sources such as agriculture, stormwater runoff and residential uses.
- (D) Organic chemical contaminants including synthetic and volatile organics, which are by-products of industrial processes and petroleum production and can also come from gas stations, urban stormwater runoff and septic systems.
- (E) Radioactive contaminants which can be naturally occurring or be the result of oil and gas production and mining activities. In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which must provide the same protection for public health.

Special Notice for the Elderly, Infants, Cancer Patients, people with HIV/AIDS or other immune problems:

You may be more vulnerable than the general population to certain microbial contaminants, such as Cryptosporidium, in drinking water. Infants, some elderly or Immuno-compromised persons such as those undergoing chemotherapy for cancer; those having undergone organ transplants; those who are undergoing treatment with steroids and people with HIV/AIDS or other immune system disorders can be particularly at risk from infections. You should seek advice about drinking water from your physician or health care provider. This is an annual report on the quality of water delivered by the City of Euless. It meets the federal Safe Drinking Water Act (SDWA) requirements for "Consumer Confidence Reports" and contains information on the source of our water, its constituents and the health risks associated with any contaminants. The data presented in this report is from the most recent testing done in accordance with regulatory requirements. Safe water is vital to our community. Please read this report carefully and, if you have any questions, call the numbers listed on the back of this brochure.

The City of Euless drinking water meets or surpasses all federal and state drinking water standards.

Water Source

The City of Euless is supplied by surface water from the Trinity River Authority. These waters originate from Cedar Creek and Richland Chambers Lakes. From there, it is sent to the Trinity River Authority's Mosier Valley water treatment plant. After treatment, the water is pumped through three transmission lines to various parts of our city. The City of Euless also obtains water from the Trinity Aquifer, through the use of three wells. This water source is drawn from a depth of 1,500 to 1,800 feet. The water is contained between two layers of solid rock and is naturally purified, therefore making it a reliable source of water for treatment and distribution.

What Does This Table Mean?

The table shows the results of our water-quality analyses. Every regulated contaminant that we detected in the water, even in the most minute traces, is listed here. The table contains the name of each substance, the highest level allowed by regulation (MCL), the ideal goals for public health, the amount detected, the usual sources of such contamination, footnotes explaining our findings and a key to units of measurement. Definitions of MCL and MCLG are important.

Maximum Contaminant Level or MCL: The highest level of contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal or MCLG: The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
