The awards were based upon low bid per item and contained options to renew for two (2) additional twelve (12) month periods at the same prices. Reliable Chevrolet elected not to renew Items 13 and 14 because items were discontinued. Jerry's GM and Meador Dodge elected not to renew.

The vendors notified Purchasing in writing that their prices will remain firm through September 25, 2014 or through the current year model build-out date (whichever occurs first). Transportation Services notified Purchasing in writing that they are pleased with the above listed vendors.

Therefore, it is the joint recommendation of Transportation Services and Purchasing that the Commissioners Court approve the renewal of Bid No. 2012-151, Annual Contract for Purchase of Police Package Vehicles, for another twelve (12) month period.

FISCAL IMPACT:

Expenses for last year were approximately \$416,702.00. Orders are placed on an as-needed basis. The forty-nine (49) entities that utilized this bid last year had expenses of approximately \$9,692,000.00 as follows:
