INTRODUCTION

On September 23, 1950, voters incorporated the municipality of Euless. It was abolished in an election on January 3, 1953. Then, on February 21, 1953, voters incorporated the municipality again. Following is a time line of the incorporation, disincorporation (the word commonly used for abolishing the corporation) and incorporation. Following the time line are copies of pages from Tarrant County Commissioners' Court Minutes detailing the process, plus copies of some pertinent newspaper articles. The newspaper articles are some that I have had for a long time. I have not done an exhaustive search of newspapers for all articles about the process. The time line is based only on the Commissioners' Court Minutes and the newspaper articles that follow.

TIME LINE

1950

August 30--In response to a petition presented to the Tarrant County Commissioners' Court by 22 Euless residents for an election to incorporate the "Town or Village of Euless", the Tarrant County Judge orders an election to be held on September 23. (*Tarrant County Commissioners' Court Minutes*, vol. 43, pp. 571-575.)

September 23--Election is held, with 48 votes in favor of incorporation and 19 against. (*TCCC Minutes*, 43:571-575; *Fort Worth Star-Telegram*, Morning, December 3, 1952.)

October 2--Tarrant County Commissioners' Court certifies results of incorporation election. (*TCCC Minutes*, 43:571-575.)

November 11--Election of officials for the "City of Euless;" Mayor elected, R. W. Fuller; City Marshall, E. V. Anderson; Aldermen, C. A. Horton, S. W. Mills, A. E. Tillery, W. T. Arnett, G. L. Anderson. [It was not until November 13, 1952, that County Commissioners' Court certified results of this election; G. L. Anderson probably should be G. L. Anders.] (*TCCC Minutes*, 44:564-565.)

1951

April 3--Euless' second municipal election is held (this is election day for most Texas municipalities); with approval of the town aldermen, Mayor R. W. Fuller scratches his name off the ballot after polls open; the election had been declared invalid by April 12 and a new election ordered. (*Fort Worth Star-Telegram*, April 12, 1951.)

September--Mayor is Homer Fuller and Councilmen are Steve Huffman, Tracy Arnett, Comer Horton, Albert Tillery and Troy Fuller; the City Council is negotiating with Wisenbacker, Fix & Associates of Tyler for installation of a water system. (*Fort Worth Star-Telegram*, September, 1951.)

October 1--City Council grants Wisenbacker, Fix & Associates a thirty-year franchise to serve Euless with water; city has option to purchase system six months after start of operation; former Mayor R. W. Fuller has sold a water well to the water company. (*Fort Worth Star-Telegram*, October 2, 1951.)

October 5--City Fire Chief Johnnie Edwards, also Euless School Superintendent, expresses pride in new water system, which will improve the city's fire fighting ability. (*Fort Worth Star-Telegram*, Evening, October 5, 1951.)

October 17--City Council has set tax rate of \$1 per \$100 valuation and tax statements will be mailed out soon for the first time. (*Fort Worth Star-Telegram*, October 17, 1951.)

1952

August 18--City Council discusses delinquent taxes of about \$1,500, representing about 45% of expected revenue. (*Fort Worth Star-Telegram*, August 15, 1952.)

November 13--County Commissioners' Court certifies election of city officials held on November 11, 1950. (*TCCC Minutes*, 44:564-565; *Fort Worth Star-Telegram*, Morning, December 3, 1952.)

December 3--A petition signed by Euless voters has been presented to the County Commissioners' Court for an election to abolish the city; the tax rate is 75 cents per \$100 valuation. (*Fort Worth Star-Telegram*, Morning, December 3, 1952.)

December 10--In response to a petition presented to the County Commissioners' Court by 44 Euless voters for an election to abolish the incorporated "City of Euless," the County Judge orders election to be held on January 3, 1953. (*TCCC Minutes*, 44:608-610.)

1953

January 3--Election is held, with 43 votes in favor of abolishing the incorporated City of Euless and 39 against. (*TCCC Minutes*, 44:608-610.)

January 8--County Commissioners' Court certifies results of election abolishing the city. (*TCCC Minutes*, 44:608-610.)

February 4--Petition by Euless residents for an incorporation election is presented to County Judge. (*Fort Worth Star-Telegram*, Morning, February 5, 1953.)

February 6--In response to a petition presented to the County Commissioners' Court by 47 Euless residents for an election to incorporate the "Village of Euless", the County Judge orders an election to be held on February 21. (*TCCC Minutes*, 45:31-34.)

February 21--Election is held, with 59 votes in favor of incorporation and 27 against. (*TCCC Minutes*, 45:31-34.)

February 23--County Commissioners' Court certifies results of incorporation election. (*TCCC Minutes*, 45:31-34.)

February 24--County Judge orders election for officers of the "Village of Euless" to be held on March 21. (*TCCC Minutes*, 45:31-34.)

March 21--Election of officers for the "Village of Euless;" Mayor elected, Joe Umphress; Marshall, E. V. Anderson; Aldermen, J. S. Anderson, M. L. Anders, Ernest Millican, Jr., W. H. Fuller, R. E. Tillery. (*TCCC Minutes*, 45:62-63.)

March 27--County Commissioners' Court certifies election of village officers. (*TCCC Minutes*, 45:62-63.)

This, the 30th day of August, 1950, came on to be heard and considered by the County Judge of Tarrant County, Texas, the petition of twenty (20) inhabitants of the herein after described town or village of Eules, Tarrant County, Texas, for an order of election of such town or village for the purpose of enabling the inhabitants of said town or village to determine whether or not the town or village of Eules, Texas, shall be incorporated under the laws of the State of Texas, and it appearing to the undersigned county judge that such petition was duly and properly filed on the 30th day of August, 1950, and that said petition was duly signed by at least twenty (20) inhabitants of said town of Eules who are duly qualified electors under the laws of the

State of Texas:

Now, therefore, by virtue of the authority vested in me under Article 1133 et seq. of Title 28, Chapter 11, of the Revised Civil Statutes of the State of Texas, I, Gus Brown, County Judge of Tarrant County, Texas, do hereby order that on the 23rd day of September, 1950, at the Public School in Euless, Texas, an election shall be held for the purpose of enabling the inhabitants of the Town of Euless, Texas, to determine whether or not the said town of Euless, Texas, as designated by the map or plat attached to aforesaid petition, shall be incorporated under the laws of the State of Texas.

It is further ordered that notice of said election shall be posed in three public places in the town or village of Euless for at least ten (10) days before the date of such election aforesaid as required by law.

That the polls shall be open for such election at the Public School in Euless, Texas on September 23rd, 1950, between the hours of 7 A. M. and 7 P. M.; Mrs. S. W. Mills, who is an inhabitant of the town of Euless and a duly qualified elector is hereby appointed manager and the person in charge of said election, and she shall appoint two judges and two clerks to assist in such election.

No person shall vote at such election unless he or she has attained the age of twenty one years, and unless he or she shall have resided in the town or village of Euless for the six months next preceding August 20, 1950, the date of filing of the aforesaid petition, and unless he or she is otherwise^a duly qualified voter under the constitution and laws of the State of Texas. All votes of such election shall be by ballots, and voters desiring the incorporation of the town of Euless shall place upon their ballots the word "corporation", and voters not desiring the incorporation of the town of Euless shall place upon their ballots the words "no corporation".

On or before the tenth day after such election, the person holding such election shall make due returns of all the votes cast at the above designated voting place for and against the said proposition to the county judge of said county.

A motion was made by Commissioner Wright, seconded by Commissioner Minton and carried that all the proceedings of the Election for Abolishment of the Corporation of the Town of Euless, Texas, be placed on the Minutes of the Commissioners' Court as requested by County Judge, Gus Brown. Proceedings as follows:

ELECTION ORDER

On this the 10th day of December, 1952, came on to be heard the petition of a majority of the qualified resident property taxpayers and qualified voters of the incorporated City of Euless, Tarrant County, Texas; said petition filed herein on the 1st day of December, 1952, praying that this Court and the County Judge order an election to be held in such incorporated City of the purpose of enabling the qualified electors thereof to determine whether such corporation should be abolished; and it appearing to the Court that such petition is in due form and that the requisites of the applicable laws of the State of Texas have been met, and that the signatures on such petition are the valid signatures of those named as petitioners, and that all of said petitioners are qualified electors as that term is defined in Article 1242, Revised Civil Statutes of Texas, and that said petition should be granted:

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that on the 3rd day of January, 1953, at First Methodist Church in the City of Euless, Tarrant County, Texas, an election be held for the purpose of submitting the question of whether or not said corporation should be abolished and dissolved to a vote of the qualified electors of said incorporated City of Euless;

that on the aforesaid date and place voting polls be kept open between the hours of 7:00 A. M. and 7:00 P. M., and that only those persons who are qualified under the terms of Article 1243, Revised Civil Statutes of Texas, be allowed to vote, said article providing in substance as follows:

"All persons who are legally qualified voters of the State of Texas and County of Tarrant, and are resident property taxpayers in the City of Euless, as shown by the last assessment roll of such City of Euless, shall be entitled to vote in such election."

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the ballot to be used at such election shall be in the following form:

No. _____ FOR Abolishment AGAINST Abolishment VOTER: Please scratch out the way you do not intend to vote, leaving your preference unmarked.	No. _____ NOTE: Voter's signature to be affixed on the reverse side.

IT IS FURTHER ORDERED that the posting of three copies of this order at three public places in the City of Euless for at least ten days immediately preceding the date of said election shall be sufficient notice to the voters of said City of Euless, as required by law.

S. W. Mills is hereby appointed as presiding officer of said election, and shall select two judges and two clerks to assist him in holding said election. Said election shall be otherwise held in the manner prescribed for holding elections in other cases.

If the majority of the qualified voters who vote at said election are in favor

of the abolishment of the corporation of the City of Euless, the election officer is to certify this fact to the County Judge within ten days from the date of holding of said election.

Eules and Hurst in Race to Win Title As 'The Metropolis of Highway No. 183'

Two recently incorporated towns—Eules and Hurst—are in a race for population, new homes, industries and the title of "metropolis of Highway 183" between Fort Worth and Dallas.

Hurst is two jumps ahead of Eules. And Eules was near one step ahead of Hurst Friday.

Hurst already has the Bell Aircraft Helicopter plant under construction and a better start than Eules on new residences. But Eules counters the Bell plant with being nearer to Greater Fort Worth International Airport.

And Eules appears to be several weeks ahead of Hurst in obtaining a water supply, first requisite for new homes and FHA loans.

The Eules city council is in recess from a Monday night meeting and final approval with Wisenbaker, Fix & Associates of Tyler for installation of a water system.

Option on Purchase.

Eules is retaining an option to purchase the water system after six months from the start of operation but the hitch—the price the Tyler firm will ask for the plant.

The franchise will cover a 30-year period.

The water people want to be assured of 110 customers. Eules had 102, but they rustled up eight more and that includes just about every domicile and store in town.

The firm plans to install a 75,000-gallon overhead reservoir, drill a deep well, lay eight and six-inch mains, install meters, 12 fire plugs and charge a \$50 tap fee.

Rate schedule has been tentatively set at \$4 for the first 3,000

gallons, 50 cents for the next 7,000 and 35 cents for all over.

Mayor is Homer Fuller. Councilmen are Steve Huffman, Tracy Arnett, Comer Horton, Albert Tillery and Troy Fuller, nephew of the mayor.

Eules has a fire truck, donated by a Eules ranchman, and equipped with \$1,200 given by Tarrant County. Paul Hart gave the fire department two tires.

Eules is about to buy another truck from Rusk for \$1,000 and then they'll use the present truck for fighting grass fires in an area bounded by the Dallas County line, Trinity River, Smithfield Rd. and Randol Mill Rd.

Fire chief is a former fire-brand teacher of basket ball, School Supt. Johnny Edwards, lately of TWC.

Land Prices Soar.

Fort Worth real estate developers have been paying terrific prices for land between Eules and the airport for residential development.

In Hurst the town's city council is ready to begin final talks on a water system.

"We're on two deals but we are going slow," says Mayor T. J. Page, retired Fort Worth mail clerk.

"We don't want to tie ourselves up too long with a water franchise," he added.

Page said that Hurst proposes to have a zoning ordinance, establish fees for building permits but will try to avoid ad valorem taxes.

Will Work Gradually.

"We will have to do these things gradually, there will always be something to be done just like Fort Worth and Dallas are always doing something," the mayor said.

Hurst has ideal locations for homes in wooded tracts and in open areas. Former County Commissioner Jess Holder recently sold acreage at Hurst for home development.

The Hurst council includes J. H. Spencer, W. M. La Cava, W. J. Collier, Thomas Koon, Pipkin, City Marshall Longley, James who resides just outside limits but one of the town's biggest boosters, is the city secretary and treasurer.

EULESS, Oct. 2 (SpI).—A deep water well has changed hands here with Wisenbacker, Fix & Associates of Tyler making the purchase from R. W. Fuller, former mayor of Euless.

The new owners will drill a second well, part of a plan to assure Euless of an adequate water supply. The East Texas firm recently obtained a 30-year franchise to serve Euless with water.

Eight-inch lines are being connected to a 250,000-gallon surface storage tank and a large pump is planned for the Fuller well. Operation is expected in two weeks.

He's Proud of Water System

Former Basket Ball Coach Is Now Chasing Blazes as Euless' Fire Chief

EULESS, Oct. 5.—A former basketball coach is now putting out fires at Euless.

Fire Chief Johnny Edwards, lately of the TWC Rams, has the water, a fire truck and 12 brand new fire plugs and a community of volunteers to do the job.

Now superintendent of Euless schools, Edwards is proud of Euless' new water system.

"We didn't have any pressure before and we'd have been in a bad fix if we'd had a fire," Edwards said, as he showed two of his American history pupils how to uncap a fire plug.

Also proud of the system are Mayor Homer Fuller and his brother, Warren Fuller, a former mayor and former owner of the Trinity deep well which is now supplying Euless with water.

Located in Warren Fuller's back yard, the well has been tied in with eight-inch mains, part of the new water system installed by Wisenbacker, Fix & Associates of Tyler.

In a few days the water will be flowing into a 250,000-gallon ground storage reservoir, located in north Euless on the highest spot in town.

An electric pump has been in-

stalled at the Fuller well and the old pump and tank has been sold to Smithfield.

"Very few towns start off a water system with eight-inch mains," Mayor Fuller said. "If we grow, we'll be ready and we're going to get lower fire insurance rates."

Euless is expecting a substantial growth in 1952, when the Greater International Airport goes into operation.

Acreage here is being set aside for future development for a large housing project.

Water is going to help the home builders obtain loans.

Eules to Discuss Delinquent Taxes At Next Meeting

EULESS, Aug. 15 (Sp).—The Eules city council will meet at 8 p. m. Monday to discuss a possible solution to delinquent tax cases blocking construction of a new Community Center building.

Mayor H. H. Fuller said Friday he did not know exactly what could be done but that something is necessary.

The taxes due—about \$1,500—represent about 45 per cent of expected revenue.

The proposed building will house the fire department and provide office space which will be rented to business concerns. The building will serve as a social and civic center.

County Examines Petition To Disincorporate Euless

The county tax office was checking late Tuesday on the validity of signatures on a petition filed by Euless residents seeking disincorporation of the city.

The petition, signed by 47 persons, was filed in the office of County Judge Gus Brown earlier. County Assessor-Collector Stewart must determine whether the signatures are those of qualified property owners before an election can be ordered.

S. W. Mills, defeated for alderman in April, circulated the petition for disincorporation. He also was one of the persons who circulated a petition to incorporate in 1950.

The city was incorporated

Sept. 23, 1950, after a special election. The action was not approved until Nov. 13, 1952, when the results of the election were presented to Commissioners Court.

Mills contends that residents of Euless are not receiving services in proportion to taxes paid.

A city official said that while very little in services has been offered the residents, plans for the future call for an expanded municipal program including a new fire truck, a fire house and police protection.

"We had hoped some day to build a city hall and operate like a city should be operated," he reported.

Other city officials said disincorporation will mean the loss of the present municipal tax of 75 cents per \$100 valuation.

Eules Residents Petition Judge for Another Election

The on-and-off incorporation issue at Eules was on again Wednesday as a petition bearing 46 names and requesting an election on the question was filed with County Judge Gus Brown.

Residents of Eules voted last month to disincorporate the city government.

Eules was incorporated Sept. 23, 1950 after a special election. The action was not approved until Nov. 13, 1952 when the election results were presented to Commissioners Court.

On Dec. 2 a petition was filed with Judge Brown asking that he call an election for dissolution of the city government. Residents voted 43 to 39 for dissolution in

the January election.

Wednesday's petition was headed by the name of James A. Puckett. The names on the petition must be checked by the county clerk's office before Judge Brown can call an election.
